WAGE

1. What is basic wage?

"Basic Wage" means all remuneration or earnings paid by an employer to a worker for services rendered on normal working days and hours but does not include cost-of-living allowances, profit sharing payments, premium payments, 13th month pay or other monetary benefits which are not considered as part of or integrated into the regular salary of the workers on the date the Act became effective. (RA 6727)

2. What is statutory minimum wage?

"Statutory -Minimum Wage" is the lowest wage rate fixed by law that an employer can pay his workers. (RA 6727)

3. Who are excluded from the coverage of the Title on Wages of the Labor Code?

The provisions of this Title shall apply to employees in all establishments and undertakings whether for profit or not, but not to government employees, managerial employees, field personnel, members of the family of the employer who are dependent on him for support, domestic helpers, persons in the personal service of another, and workers who are paid by results as determined by the Secretary of Labor in appropriate regulations. (ART. 82, Book III Conditions of employment)

4. May an employer make any deduction from the wages of his employees? NO

ART. 113. Wage deduction. - No employer, in his own behalf or in behalf of any person, shall make any deduction from the wages of his employees, except:

- (a) In cases where the worker is insured with his consent by the employer, and the deduction is to recompense the employer for the amount paid by him as premium on the insurance;
- (b) For union dues, in cases where the right of the worker or his union to check-off has been recognized by the employer or authorized in writing by the individual worker concerned; and
- (c) In cases where the employer is authorized by law or regulations issued by the Secretary of Labor and Employment.

5. What is a wage distortion?

"Wage Distortion" means a situation where an increase in prescribed wage rates results in the elimination or severe contraction of intentional quantitative differences in wage or salary rates between and among employee groups in an establishment as to effectively obliterate the distinctions embodied in such wage structure based on skills, length of service, or other logical bases of differentiation. (RA 6727)

6. What are the elements of wage distortion?

The elements of Wage Distortion had been clearly established in the case of Prubankers Association vs. Prudential Bank and Trusts Co. GR # 131247, January 25, 1999.

- a. Existing hierarchy of positions with corresponding salary rates
- b. Significant change in the salary rate of a lower pay class without a concomitant increase in the salary rate of a higher one
- c. Elimination of the distinction between the two levels
- d. Existence of the distortion in the same region of the country
