

What is Actuarial Valuation?

- An actuarial valuation is a type of appraisal which requires making of
 - (1) financial assumptions
 - (2) demographic assumptionsin order to estimate future liabilities. The assumptions are typically based on a mix of
 - (a) analytics,
 - (b) statistical studies
 - (c) and experienced judgment.

Actuarial valuations in India are mostly done for **compliance of accounting of Employee Benefits under :- AS 15 (revised, 2005), IAS 19 or Ind AS 19** as they are mandatory requirements issued by the relevant accounting body. However, actuarial valuations are also done for **valuations of intangible assets like brand valuation** or to make **provision for contingent liabilities like warranties** given to customers.
