Die Verhandlungsliteratur stuft viele dieser Lügen ausserhalb des Vertragsgegenstands und des Preises als akzeptierte Geschäftspraxis ein. Ein erster Blick auf 123 Abs. 1 Abs. 1 Alt BGB Anfechtung wegen arglistiger Täuschung legt hingegen nahe, dass vorsätzliche, kausal gewordene Täuschungen ausnahmslos als unrechtmässig anzusehen sind.
