SUBJECT: Trademark Infringement in Videos

TRADEMARK INFRINGEMENT IN VIDEOS

This memo addresses whether, and under what context, an unpermitted use of a trademark in a stock video necessarily leads to a finding of trademark infringement or trademark dilution. This question is important for two reasons. First, content producers are currently spending¹ large sums of money to clear rights to every product that appears in their production.² They do this because it is cheaper to clear the rights to the product than it is to fight a future trademark infringement case.³ Second, small independent content producers are forced to expend time and energy removing products appearing in

As a practical matter, however, industry custom, insurance requirements, and fear of trademark litigation have combined to create a "clearance culture" that forces creators to seek permission for the use of marks. This increases transaction costs and leads, ultimately, to stifled creativity and chilled speech.

Average litigation costs for a trademark infringement lawsuit is \$600,000.00 Report of Economic Survey published by the American Intellectual Property Lawyers Association. Other risks to trademark litigation include possible injunction. Potential claims include tarnishment, dilution, unfair competition, product disparagement, and false endorsement under the Lanham Act, among others.
