Introduction to Crime Scene Investigation (CSI)

- The goal of crime scene investigation is to recognize, document and collect evidence at a crime scene
- A single hair or clothing fiber can allow a crime to be reconstructed and lead police to the responsible person
- Solving a crime depends on piecing evidence together to form a picture of what happened at the scene

Principle of Exchange

- Established by Dr. Edmund Locard, who directed one of the world's first forensic labs in Lyon, France
- *Locard's Principle of Exchange:
 - When a person comes in contact w/ an object or another person, cross-transfer of physical material can occur
- Evidence can be found on both persons or objects
 - This evidence acts as a silent witness to the crime
 - Examples: Hair, skin cells, clothing fibers, pollen, make up, debris from clothing, glass fragments

Principle of Exchange

- This physical evidence is called trace evidence
 - Trace evidence: small but measurable amounts of physical/ biological material found at a crime scene
 - Common examples: pet hair on rugs/clothes, fibers from clothing, hair on a brush, a drop of blood, soil tracked into a house on a pair of shoes, fingernails, paintchips, a used tissue, and broken glass
- Second Part of Locard's principle states that the intensity, duration, and nature of the materials in contact determine the extent of the exchange
 - Example: a fist fight will leave more evidence as opposed to brushing against someone's arm
