PART III turns to drafting rules for good writing and to techniques for enhancing clarity and avoiding ambiguity. PART V shows students how to integrate everything they have learned: how to organize a contract, how to use precedents, and how to review and comment on a contract. PART VI addresses ethical issues that arise in drafting. PART VII provides additional exercises, presents a five-prong framework for considering business issues that appear in almost every transaction, money, risk, control, standards, and endgame. Chapter 17, *Adding Value to the Deal*, includes plentiful examples of well-drafted provisions, many based on commercial agreements, provides exercises for use in or out of class individually or collaboratively, including contract mark-ups, new drafting, and both combined into a single exercise. It integrates a single fact pattern throughout many exercises in the book: the purchase of a jet by a never-do-well with significant financial problems and varying fact patterns relating to employment relationships and to assignment and delegation provisions, accompanied by a Teacher's Manual that includes notes explaining the answers to each exercise and answers to questions that students commonly ask, also accompanied by a website that provides all mark-up exercises that can be projected and walked through during class, a template for formatting, and multiple versions of one of the culminating exercises so that professors can use the version best suited to their classes.
