SUBJECT: Trademark Infringement in Videos

TRADEMARK INFRINGEMENT IN VIDEOS

This memo addresses whether, and under what context, an unpermitted use of a trademark in a stock video necessarily leads to a finding of trademark infringement or trademark dilution. This question is important for two reasons. First, content producers are currently spending¹ large sums of money to clear rights to every product that appears in their production.² They do this because it is cheaper to clear the rights to the product than it is to fight a future trademark infringement case.³ Second, small independent content producers are forced to expend time and energy removing products appearing in

² As a practical matter, however, industry custom, insurance requirements, and fear of trademark litigation have combined to create a "clearance culture" that forces creators to seek permission for the use of marks. This increases transaction costs and leads, ultimately, to stifled creativity and chilled speech.
