
FINANCIAL MARKET LAW – I PART

Introduction to Financial Market Law

Financial markets are regulated both by national and international regulations. There is an Italian regulation and a European Union regulation, in which we will be focusing.

What is included in the area of financial markets regulation? First the capital market functioning, so how does the capital market function: included in the area we have the market infrastructures, so all the public and private systems that provide services that allow financial transactions (es. Trading venues, all the platforms that are somehow regulated that allow the market participants to do financial transactions), and the second part is the one devoted to investment services, all that activities that are related to investment in financial instruments (es. Brokers who provide advises in purchases of financial instruments). Second we have capital market actors, which are divided into three categories: issuers, intermediaries and investors. The issuers (to issue is to put on the market something new) are all the legal entities that first develop and then sell on the market a financial instrument or a security (from this moment we use it a synonym of financial instrument), their goal is to finance their business, they might be corporations, investment trusts and governments. Investors are the counterpart of issuers, they are all individuals that buy securities on the market (they are the lenders, they lend money to the borrowers, the issuers). Third actor of the market are the intermediaries, the middle ground between the issuers and the investors. The intermediaries are all the institutions that somehow deal with financial activities, for instance banks, funds, insurance companies. We need professionals because they can suggest you better on how to invest your money based on your profile of investor. Secondly, being professionals, intermediaries have the contractual power to understand and have a complete pool of information regarding every security on the market, and somehow they bear the risk for the investor. The cost not only of knowing the information but also the cost of constant monitoring is significantly lower for someone who does it as a profession, so for the investor the cost of monitoring and knowing the information is higher.

The third part of financial market regulations regards financial instruments and products. They are all the assets that are or may be traded on a financial market. There is a basic distinction:

- cash instrument, so instruments that are based on money, and they can be:
 - equity based, like shares (which make the investor part of the ownership of the company);
 - debt based, like bonds (the investor just gives a loan);
- derivatives instruments: all the instrument not based on cash but whose value is based on the underlying asset, for instance options and futures.

The last part of financial market regulation are all the rules whose purpose is to mitigate market failures. All the sensitive information are subject to disclosure, because they have an significant effect on the market so they can not be held privately. Then there is all the regulation regarding market abuse and insider trading. All these information exist to avoid market failure, to guarantee the correct going on of the market.

Financial markets are part of the bigger market economics, where we have lenders and borrowers. These two parts conclude contracts. In an ideal world where there is a perfect market, there would be no need for regulations: if the parts of the contract can reach the most efficient solution by themselves, the market wouldn't have to be regulated in any way. Although in the real world there is no such thing as a perfect market: rules exists to mitigate all the problems that can come from the day by day contracting in a financial market. The law intervenes when and where there is a risk of market failures, meaning those situations where all the parts can not reach an efficient solution.

The problems we are referring to are:

- information asymmetry: normally the borrowers possess more information about the security compared to the lenders, because they issue the financial instrument itself. The lenders do not have the same set of information. If no rule would be there to mitigate this problem, in order to obtain said information, the lender would have to sustain such cost that eventually the purchase of the financial instrument wouldn't be efficient at all, so there wouldn't be contracts and the financial market would stop;
- moral hazard: when the borrowers has access to all the information, he could potentially report to the market a situation that is different from the reality. Without regulations there might be an inefficient allocation of resources, because the market wouldn't be able to push out the inefficient issuers;
- agency problems: all the situations where you have on one had the agent and on the other the principals: the typical situation in which this happens is the manager (agent)-shareholders (principals) situation. In this particular case, the shareholders give the manager the task of managing the company for them. The better
