ABSTRACT

In recent days Enterprises were suffering due to economic crisis due to Impacts of COVID19 which drives towards the compression of Growth of gross domestic product (GDP) results in revenue loss, additional expenses and increase in operation & manufacturing cost. Corporate Firms look this as an opportunity for their benefit by acquiring such Firms through financial transactions. In other hand to strengthen the Firm financial stability, product brand, business portfolio and market competitiveness firms were looks for an opportunity to merger with their competitors during era of economic crisis or normal situation or both. Various researchers were carried out research on M&A deals of firms which does. Merger /amalgamation or acquisitions transaction process & its prospects. The purpose of this paper aims to study & analyse the Strength, Weakness, Opportunities and Threats of Mergers and Acquisition from the Firm's Customer perspective through questionnaire survey, 163 respondents of customer/ product users have been participated in this survey from various regions of India with reference to multi-diversified industrial sector in 2 sections to identify & conduct SWOT analysis for Mergers and Acquisitions Impacts from their perspective. The results show that Mergers of firms have Strength (7) and Opportunities (8) has highest mean, Weakness (4) and Threats (4) in the mergers are in same level and indicated F value 2.47 from customer perspective. Further, the result shows that the Acquisitions of firms have moderate mean in both Opportunities (5) and Threats (5) within same level, Strength (4) has lower mean and highest mean on Weakness (6) having F- value 1.58. Hence, Mergers has more impact & significance than acquisitions from customer perspective. However, the demonstrated results are limited with 163 respondents through questionnaire survey.
