**Adjustments for the New Partner:** When a new partner is admitted, the existing partners must make adjustments to account for the new partner's share of profits and any payments made for goodwill.

**Adjustment Entry:**

Record the cash or other consideration received from the new partner.

Adjust the capital accounts of existing partners.
