

Audit change data shows differences at Big 4 firms

In the churn for new auditors, one Big 4 firm has held steady with its net number of audit clients while three others have seen net losses numbering in the 20s. **Tammy Whitehouse** has the results of the latest data from Audit Analytics.

For a second straight year, one Big 4 firm has held steady with its net number of audit clients while three others have seen net losses numbering in the 20s.

Data compiled by Audit Analytics found net gains for each of the four Big 4 firms. Changes show General lost 160 net engagements ending the last three-year period (the three that lost net client change have it less than last year); the next three gained 160 net engagements, with 4 being Deloitte.
