Dies lässt sich durch eine bessere Analyse des Zielunternehmens vermeiden. Um eine schlechte Transaktion zu vermeiden, bieten unter anderem Wirtschaftsprüfungsunternehmen sogenannte Due Diligence Prüfungen an. Hier wird das zu übernehmende oder für den Zusammenschluss ausserkorene Unternehmen auf Risiken und auch mögliche Synergien hin überprüft. Dadurch werden die Informationsasymmetrien in der Verkaufsverhandlung abgebaut. Due Diligence Untersuchungen werden nicht nur für Firmen durchgeführt, sondern auch für Teile von Firmen oder einzelne Assets, z.B. Immobilien. Der Schwerpunkt dieser Arbeit liegt jedoch auf der Akquisition ganzer Firmen. Da es keine gesetzlichen Vorgaben für die Durchführung einer Due Diligence gibt, im Gegensatz z.B. zu der Prüfung von Jahresabschlüssen, haben die prüfenden Berater die Möglichkeit, auf das Ergebnis der Due Diligence Einfluss zu nehmen. Dies kann potentiell zu Interessenkonflikten führen, wie sie beispielsweise bekannt sind aus dem klassischen M&A, wie es von Investmentbanken durchgeführt wird. Die eine am Wert der Transaktion orientierte Entlohnung erhalten und daher daran interessiert sind, dass die Transaktion zustande kommt und zwar zu einem hohen Preis, oder von Rating Firmen, die ihren eigenen Auftraggeber kritisch überprüfen sollen und dabei nicht daran interessiert sind, ihren Mandanten aufgrund zu schlechter Bewertung zu verlieren. Es ist daher zu untersuchen, ob auftretende Interessenkonflikte gelöst werden können. Ich werde in dieser Arbeit zunächst mit einer allgemeinen Beschreibung von Due Diligence Prüfungen beginnen, erklären, wann und wozu sie eingesetzt werden, welche Arten von Due Diligence unterschieden werden und wie bei der Prüfung vorgegangen wird. Im Anschluss gehe ich auf den theoretischen Hintergrund von Prinzipal-Agent-Interessenkonflikten ein und erläutere, inwiefern die Theorie auf Due Diligence Prüfungen anwendbar ist. Zum Schluss wird am Beispiel von EY gezeigt, wie die Interessenkonflikte gelöst werden und die Unabhängigkeit der Berater somit gewährleistet wird.
