Although the government is planning to strengthen government oil distribution, it must be aware that petroleum markets are becoming more free. The state has to understand oil market trends, understand more oil resources, and the world oil price fluctuations and trends, and develop efficient strategies. This is especially obvious in the Middle East.<sup>10</sup> For example, Algeria has more oil and a substantial domestic oil market, although the country has nationalized them. Although world oil prices are fluctuating, these countries could greatly increase their income by increasing oil exports.
