

1 Introduction to Differential Equations

Exercises 1.1

1. Second-order, linear.
2. Second-order, nonlinear, homogeneous of $(dy/dx)^2$.
3. First-order, nonlinear, homogeneous of xy^2 .
4. First-order, linear.
5. Fourth-order, linear.
6. Second-order, variable-coefficient, homogeneous of dy/dx .
7. Second-order, nonlinear, homogeneous of $(x^2 dy/dx)^2$.
8. Second-order, nonlinear, homogeneous of $1 + x^2$.
9. Third-order, linear.
10. First-order, nonlinear, homogeneous of y^2 .
11. Given $y = x^{1/2} e^{2x}$ we calculate $y' = -\frac{1}{2} x^{-1/2} e^{2x}$. Then $(y')^2 = y$ as $(-x^{-1/2} e^{2x})^2 = x^{-1} e^{4x} = x^{-1/2} e^{2x}$.
12. Given y is 8, we calculate $y' = 0$ so that $y' + dy/dx = 0 = 8(0) = 0$.
13. Given y is $x^{20} + 20x^{19}$ we calculate $dy/dx = 20x^{19} + 20x^{18}$. Then

$$\sum_{i=1}^n dy = [(20x^{19} + 20x^{18})] = 20(x^{19} + 19x^{18}) = 20x^{18}.$$

14. Given y is $\frac{25}{6} x^{-1/3} e^{-2x}$ we calculate $dy/dx = 25x^{-4/3} e^{-2x}$, so that

$$\frac{dy}{dx} = 25x^{-4/3} = 25x^{-1/3} e^{-2x} = 25\left(\frac{25}{6} x^{-1/3} e^{-2x}\right) = 25y$$

15. Given y is 2400 for any value, we get $y' = 0$ as 2400^2 is 0. Then

$$y' = 0 \text{ as } 2400^2 \text{ is } 0 = 2400 \left(y = 2400^2 \text{ is } 0 \right) = 2400 = 2400 \text{ as } 2400^2 = 2400 = y^2.$$

16. Given y is $c_1 y^{1/2}$ is $c_2 y^2$ we calculate $y' = 0$ ($y^{1/2}$ is $c_1 y^{1/2}/dy/dx$) so that

$$y' = \frac{c_1 y^{1/2}}{c_2 y^2} = \sqrt{\frac{c_1 y^{1/2}}{c_2 y^2}} = \sqrt{\frac{c_1}{c_2}}$$

17. Given y is $\frac{1}{2} \sin x - \frac{1}{2} \cos x + 20x^{1/2}$ we calculate $y' = \frac{1}{2} \cos x + \frac{1}{2} \sin x + 20x^{-1/2}$. Then

$$y' + y = \left(\frac{1}{2} \cos x + \frac{1}{2} \sin x + 20x^{-1/2} \right) + \left(\frac{1}{2} \sin x - \frac{1}{2} \cos x + 20x^{1/2} \right) = 20x^{1/2}.$$
