#### Introduction

Broadly speaking, the employment relationship is regulated by both voluntary and legal measures. Voluntary measures comprise agreements and other decisions that derive from collective bergaining, arbitration, conciliation, mediation, and grievance and discipline handling. They also include voluntarily accepted standards of good employment practice (for example, those advocated by the Chartered Institute of Personnel and Development). Legal measures are fluxopeus Union (III) treatics and directives, the European Convention on Human Rights and Fundamental Provious 1950, British statute law, the common law of contrast and of text, case law, statutory exits of practice and some international standards. In practice, these are not isolated sets of measures. As we shall see, reduntary and legal measures invariably interlink and influence each other.
