LA RIFORMA DEL SISTEMA DI ACCOGLIENZA E INTEGRAZIONE PER I RICHIEDENTI IL TITOLO DI PROTEZIONE INTERNAZIONALE

Abstract: Con il voto del d.l. 128/2020 il legislatore compie una decisiva svolta in direzione dell'accoglienza e integrazione dei richiedenti asilo e rifugiati e inserisce una fase di riorganizzazione delle attività di assistenza internazionale relativa tra sistemi di accoglienza e integrazione come elementi inscindibili di un percorso che porta all'asilo politico della persona. Fatto parte integrante del quadro della riforma di accoglienza e asilo è l'istituto affermato alla rete degli Enti locali (il quale dal 2008/2009 è stato rinominato Sistema di accoglienza e integrazione - SAI) vengono chiamati in "cooperazione differenziata" introdotta con il d.l. 128/2020 e sostituito l'organismo binario con il quale era stato previsto che gli Enti locali del SAI/SAI si occupassero di accogliere e assistere i percorsi di asilo politico e integrazione per cittadini di protezione e asilo politico non accompagnati, mentre gli uffici centrali del governo del Ministero dell'Interno, ovvero la prefettura, gestiscono un sistema minimo di attività di assistenza e prima accoglienza per i richiedenti asilo. Oltre ad intervenire nelle categorie di beneficiari che possono accedere al Sistema di accoglienza e integrazione, il provvedimento interviene sulle procedure e i servizi da garantire ai richiedenti protezione internazionale e sulle modalità di relazione tra i diversi livelli di governo coinvolti nell'implementazione delle politiche.

Abstract: With the approval of the Decree Law 128/2020, the legislator makes a decisive shift in the direction of the reception and integration of asylum seekers and refugees. It encompasses a phase of reform in which the close internationalization between the reception system and integration of migrants is strengthened. The system related to the network of local authorities (which from 2008/2009 has been renamed to the Reception and Integration System - SAI) is once again placed at the center of the reception model. The activities introduced with the Decree Law 128/2020 are diversified (the local authorities of SAI/SAI could take care of welcoming and activating integration paths only for the holders of protection and non-accompanied foreign minors, while the central government offices of the Ministry of the Interior, the Prefecture, guaranteed a minimum system of assistance services and initial reception for asylum seekers). In addition to intervening on the categories of beneficiaries who can access the reception and integration system, the measure affects the services and how they to be guaranteed to the applicants of international protection and the relationships between the different levels of government involved in the implementation of policies.
